

The answer has been in front of me all along... I just didn't realize it until recently.



AIA 2010 MEMBER DUES PAYMENT PLAN (MDPP)

We've just finished a trough year, and we're beginning to see indications that 2010 is going to be better, but no matter how the economy is doing, you need to keep your AIA membership active — And here's a good way for you to do it. If it would be helpful for you to pay your 2010 member dues in installments, AIA Las Vegas / Nevada has arranged for you to do so. We have joined the MDPP program being offered by AIA National. 2010 Dues Invoices have been mailed and emailed to the members with payments due by January 31st, 2010.

To take advantage of the MDPP program, here's the process:

Eligible members interested in participating in the 2010 Membership Dues Payment Plan will be able to enroll online at www.aia.org beginning January 4, 2010. Members will be required to authorize The American Institute of Architects to make withdrawal payments against a valid credit/debit card based on the scheduled terms for the payment of annual dues.

Members who have not renewed their membership by April 6, 2010 will be considered lapsed and will not receive member benefits until either dues payment is made in full or the member enrolls in the MDPP. The deadline to enroll is April 30, 2010. New and reinstated members are NOT eligible to participate in the MDPP.

The installment term for the 2010 plan will be for six months only, starting January 4, 2010, and ending June 30, 2010. Members need to enroll into the plan prior to April 30, 2010. Firms who choose to use the MDPP on behalf of their employees must enroll their Institute members individually online. This must also include the authorized credit or debit account from which each member's dues can be paid.

Be sure to contact the AIA LV office after January 4th, 2010 if you want to sign up for the MDPP (Member Dues Payment Plan).



The Nevada Chapter of U.S. Green Building Council (USGBC) recognized leaders in green building at its annual Leadership Awards Breakfast. In addition to the awards celebration, the Chapter welcomed new board members and its incoming President, RICK VAN DIEPEN, ASSOC. AIA.

AlA Nevada received the Advocacy By An Organization Award for our "Blueprint for Nevada." This award recognizes an individual or organization that has made a significant contribution to advancing green building in the public sector. **RIC LICATA, AIA**, Reno, NV and **J. WINDOM KIMSEY, FAIA**, Henderson, NV were named as Co-Winners.



ROTCH TRAVELLING SCHOLARSHIP

Graduates from architecture school could be eligible for the opportunity of a lifetime. The Rotch Travelling Scholarship, a two-stage design competition, furnishes one young designer with a stipend of more than \$35,000 to spend eight months traveling abroad.

To be eligible for the scholarship, candidates must be U.S. citizens under 35 years old on January 1 of the competition year, and must have:

A professional degree (BArch/MArch) from an accredited U.S. school of architecture and one year of full-time professional experience in a Massachusetts architecture firm as of January 1 of the competition year.

-or-

A professional degree (BArch/MArch) from an accredited Massachusetts school of architecture and one year of full-time professional experience in any architecture firm as of January 1 of the competition year.

Applications are due January 15. Get the scholarship guidelines and application online at rotchscholarship.org/competition.



It was FUN! Just simply GREAT FUN. Everyone who attended said so, in fact, everyone said "Let's have more meetings like this one."


