#### Project Manager Salaries Rise in the Past Year Survey Reports

Median salaries for the highest paid project manager in design and construction organizations now stands at





\$60,000, unchanged from 1995 according to the 1996 *Project Management Survey* conducted by the Association for Project Managers

(APM). Salaries of the lowest paid project manager rose \$3,000 to \$43,000. This was an increase of 7.5 percent over 1995. For the entire sample, median salaries of \$50,000 with a range of \$30,000 to \$100,000 were found. The overall experience level of project managers rose from 10 years (median) in 1995 to 12 years currently. The 22-page 1996 *Project Management Survey* is available for \$25. #### Building Department Streamlines Permit Process

In September, the Department of Buildings combined the building and electrical permit process. This change,



according to Commissioner Cherryl Thomas, is part of a two-year effort to streamline the approach to permitting.

Previously, when customers planned to do electrical work they were required to obtain both a building permit and a separate permit for electrical work. Under the new system, all applications for building permits must be accompanied by an electrical wiring permit application which has been completed and signed by a licensed supervising electrician.

When the planned work involves wiring a new building or rewiring, rehabbing or remodeling an existing building, the electrical permit application must be submitted in conjunction with the application for the general building permit in room 800 of City Hall.

Licensed electrical contractors can obtain wiring applications in room 803. Electrical contractors won't receive a separate permit for electrical work. Instead, authorization to proceed with electrical work will be granted under the single building permit.

Building and electrical permit applications must be accompanied by all required plans and load calculations dictated by various sections of the Chicago Electrical Code. The building permit applicant is responsible for ensuring these requirements are met. All electrical fees will be included in the final cost of the building permit.

The only exceptions to the merged process requirements will be those building permit applications which don't involve the installation or alteration of electrical wiring or equipment. Applications for permits involving electrical work only will continue to be received and processed by the Bureau of Electrical Inspection on the standard wiring permit application.

## Members Approve Smaller, More Effective Board

n September 24, during a special meeting of the AIA Chicago board of directors, the membership voted to approve changes to the Chapter's by-laws. The changes are a direct result of the recent membership survey and set into motion a restructuring of the board of directors.

"The new board structure will improve continuity of leadership and clarify the role of board members," said president-elect Stephen Saunders, AIA. "By reducing the size of the board, we will increase its effectiveness and be able to move quickly on issues."

In May, a survey was mailed to all architect and full associate members of AIA Chicago to measure the members' level of satisfaction, to identify reasons members joined and reasons they remain a

member, to measure members' satisfaction with specific programs and activities, to measure the importance of specific programs and activities, and to solicit suggestions for new member services and programs.

The members told us they want AIA Chicago to promote the value of the architect, they need services and benefits delivered in different ways, and they are too busy for all but the most relevant programs

"As time becomes more precious to all of us, it's important to find specific ways members can participate," Saunders said.

In response to the member survey, completed in July and reported to you in the September issue of *Focus*, the board of directors endorsed changes to better serve the membership. At the board meeting on August 27, they voted to ask the membership to approve a restructuring of the board. Members approved the changes on September 24.

The goals of these changes are to 1) focus on large issues of common concern to the whole membership; 2) target programs and services to specific groups of members by needs and location; 3) provide opportunities for participation beyond committees. In addition, they will reduce turn-over on the board, thus building expertise at the board level on issues such as promotion, government affairs, and the ever-changing needs of members.

At the meeting, committee chairs voiced a commitment to continuing communication with the board and asked that open communication remain a priority. Members expressed a desire for the board, although smaller, to remain diverse to reflect the Chapter's membership.

#### **Previous Board Structure**

The **executive committee** of the board of directors consists of the president (one-year term), president-elect (one-year term), two vice presidents, a secretary and a treasurer (all for two-year terms).

The current board structure includes **six directors-at-large**, each serving a two-year term, and **eight directors** selected from committee chairs. The directors serve for one-year.

Two directors each representing the concerns of associate and affiliate members respectively are elected to one-year terms.

The immediate past president sits on the board of directors.

An AIA Chicago delegate to the AIA Illinois board serves as a **director-at-large** on the AIA Chicago board.

The AIA regional director serves as an ex-officio director.

There are 25 members of the board of directors.

#### **New Board Structure**

**Five directors** are selected based on experience with and interest in the primary issues of concern to members. These directors will be elected to three-year terms. Committees are redeveloped into Professional Interest Areas (PIA). PIA chairs report to the board of directors quarterly.
