Awards in Architecture

Seven Indiana architects have been honored for their outstanding designs in the Indiana Society of Architect's second Triennial Awards in Architecture competition. The awards were announced at the ISA's annual banquet on May 25th.

Jury members were Mr. Charles Graves, AIA, head of the School of Architecture at the University of Kentucky at Lexington (chairman); Mr. Joseph D. Baker, AIA, wellknown Newark, Ohio, architect; and Mr. Charles Vaughn, business editor of the INDIANAPOLIS NEWS. Harry Hunter was overall chairman of the Honor Awards program this year, assisted by H. Roll McLaughlin, Charles Lowe, Roger Frey and John Guyer.

In making the presentations at the banquet, Chairman Graves quoted from the preceding Triennial Awards report in his general remarks:

"The need and use for an Honor Awards Program that will bring to the public recognition within the profession of outstanding works of architecture fulfills one of the important aspects of public information for the American Institute of Architects. The greatest awareness of the program by the general public and the influence of the awards make it essential that the jury recommend only those solutions which do in fact encourage and enlarge the visual environment through good architecture."

The specific citations for each award were:

FIRST HONOR AWARD: IRVING CONCRETE MATE-RIALS OFFICE BUILDING, Greenfield; Owner: C. C. Irving; General Contractor: A. G. Oster Company, Wilkinson; Architects: Johnson, Ritchart & Associates, Anderson.

"The architect, with clarity and simplicity, has provided a recognizable image for his client in symbolizing his product through the use of form and material. The jury was par-

ticularly pleased with the use of lighting and the sculptured wall in the solution."

FIRST HONOR AWARD: DELTA ZETA SORORITY HOUSE, Greencastle; Owner: Delta Circle, Inc.; General Contractor: Ostram Construction Company; Architect: Evans Woollen, AIA, Indianapolis.

"The solution is a direct and positive architectural statement, expressing in simplest terms the complex functioning of group living but still possessing appropriate dignity and serenity. The jury wishes to commend the clarity of structure and the selection and use of materials."

"This solution shows a warm, thoughtful use of materials without elaboration throughout the building. The jury particularly commends the architect's recognition of site in present and future development."





Mr. Walter Scholer, Jr., AIA, of Lafayette, was selected as the 1962-63 President of the ISA; Mr. Scholer has been a member of the Society's Board of Directors for the past three years, and during the last two years he served as Vice President and chairman of the ISA-AGC Joint Committee.

Elected ISA Vice President was Mr. Alfred J. Porteous, AIA, of Indianapolis, a member of the Board for the past two years, and chairman of the ISA Scholarship Committee.



Cited for design excellence by the Texas Society of Architects ... modern concrete building blends spectacular beauty with practical economies

Selected as an outstanding example of contemporary Texas architecture, the new Republic Savings and Loan Association Building was chosen for exhibition during the State Fair of Texas.

Among many interesting features, the 4-story structure with lower-level parking is distinguished for its graceful honeycomb cast concrete solar screen. It shields the massive southern exposure against peak solar heat loads yet admits plenty of daylight. Its design reduced airconditioning requirements by 10 tons, saving \$6,000 in equipment plus continuing savings in operating costs.

Fashioned with white portland cement, the lacy solar screen provides a pleasing contrast with adjacent precast concrete panels of brown and cork-colored marble aggregates. Even the concrete terrace steps and floors add decorative interest with their exposed aggregate surfaces.

Structural strength, fire-safe qualities and construction economies were important factors in the choice of concrete for this building. Time, labor and money were saved with the multiple use of forms in the building of concrete frames and pan joist floors. And because of concrete's ready availability, there was no time lost in scheduling.
