# A NEW EXECUTIVE DIRECTOR FOR INDIANA SOCIETY OF ARCHITECTS

### Harold A. Long appointed by Arthur L. Burns, AIA

On 20 April, 1972, the appointment of Harcld A. Long as new Executive Director of the Indiana Society of Architects was announced by the Society's President, Arthur L. Burns, AIA, of The McGuire & Shook Corporation, Indianapolis. The Society's action culminates a three-month screening of applicants who were interviewed for the position left vacant by the death of Don E. Gibson in October of last year. ISA members James O.
