

INDIANA AND KENTUCKY SOCIETIES TO HOLD SEPTEMBER REGIONAL CONVENTION

“MINI-GRASSROOTS” IS THEME
OF 1973 MEETING

The Indiana Society of Architects and Kentucky Society of Architects will meet September 6 through 8 at the French Lick Sheraton, French Lick, Indiana, for a stimulating but relaxing convention.

This year's thrust spotlights how AIA, ISA and KSA work for the member and the profession and will provide the opportunity for those who attend to hear, direct from Washington, what is being done to represent them at all levels of governmental and community action. Conventioneers will also be able to discuss, in sessions and informally, their ideas concerning what each organization should be doing.

An optional Training Laboratory, “The Design Impacts of O.S.H.A.”, to be held Thursday, September 6th, is an added attraction for the 1973 Convention.

Rotating concurrent sessions on Professional Practice, Public Relations, Continuing Education and Structure and Communications highlight convention activities Friday. The evening's social activities offer an exciting German Oktoberfest theme.

Several features make this year's convention even more attractive. First, registration costs have

been slashed for the regular day and one-half session to just \$5.00 for member and spouse. A special “package” which includes the Thursday special training lab on OSHA will cost a mere \$50.00 and the convention registration will be free for the member and spouse.

Next, the convention has been compacted, except for the optional items, into not over a day and one-half. The effort of Mr. Robert Kennedy, Convention Committee Chairman, and the Convention Committee is to encourage the younger practitioner and those with small offices to attend. Especially welcome are students and younger non-members. All offices are encouraged to allow as many as possible to be away for the main “mini-grassroots” day. By compacting scheduling, equivalent savings in housing costs can be realized also.

A special main address and awards presentations will conclude the main convention at noon on Saturday, with optional organized recreational activities continuing until evening.

In short, the four “C's” of the 1973 Convention logo could mean Communication, Coordination, Continuity and Conviviality. Plan your calendars now to join us at French Lick!

TWO INDIANAPOLIS CHAPTER MEMBERS SELECTED FOR INDIANA ACADEMY

H. ROLL McLAUGHLIN, FAIA, and EVANS WOOLLEN III, AIA, were among 20 Hoosiers inducted June 18, 1973, into the Indiana Academy in recognition of their contributions to culture in Indiana.

MR. McLAUGHLIN, James Associates, is a national authority on historic landmarks and a specialist in the restoration of historic buildings. Preservation officer of the Indiana Society of Architects since 1960, he is a member of the Greater Indianapolis Progress Committee and the Indianapolis Arts and Culture Committee and director of the Historic Landmarks Foundation.

Among restorations done under MR. McLAUGHLIN's direction were the Old State Bank Memorial in Vincennes, the Old Opera House State Memorial in New Harmony and the Benjamin Harrison Home in Indianapolis. MR. WOOLLEN, senior member of Woollen Associates, Indianapolis, is a trustee of the English Foundation and Crown Hill Cemetery and a member of the United States Institute of Theater Technology. From 1969 to 1972 he served on the Capital Improvements Board.

MR. WOOLLEN's designs include the Clowes Memorial Hall at Butler University and the Caroline Fesler Hall at the John Herron Art Institute. He was honored by the Indiana Society of Architects for his design of the Delta Zeta House at DePauw University and had also received recognition for his plans for several Indianapolis churches and branches for American Fletcher National Bank.

The INDIANA ACADEMY was founded in 1971 to recognize those who have contributed to Indiana through public service, higher education, arts, science and literature. Presidents of 18 independent colleges and universities affiliated with Associated Colleges of Indiana made the selections for membership.
