# THREE BUDGET HOUSES

It is a common misconception with a large number of potential clients that an architect is not interested in designing for the modest budget. The three houses illustrated here were all designed with this consideration as a point of departure, all take advantage of a compact square plan with the minimum of exterior wall and roof area and a minimum of circulation.



Total square footage: 3,000 Cost per square foot: \$10.90 This compact structure was designed to provide, within stringent budget limitations, a plan that would give maximum privacy to a family of seven. The five children range in age from 12 to 4 and a major requirement was provision of a bedroom for each in such a way that privacy for the parents was assured.

As will be seen in the plan, children occupy the lower floor and have outdoor access from the playroom around which their bedrooms are arranged.

The very steep lot was terraced for driveway access, and the upper floor is the entry level.

The lower level is of common flashed brick and supports an upper floor of wood frame. Exterior siding is rough sawn red cedar and beams are rough pine.



The site, a rather narrow but deep wooded lot sloping up from the street affords one good view through the trees towards the road to East. The problem was to gain this aspect from the house without the loss of privacy from the street and to screen the car parking from both the main entrance and street. A square plan was adopted to give maximum floor space on one level raised above the site in order that the inset deck cuts off the view from the street to the central living room lit from the deck.

This allows the use of the entire living room and deck area to be experienced as one space, divided only by sliding glass doors. The views to the North, South and West have been controlled by the retention of trees and further planting is planned due to the unsightly adjacent properties.

The bedrooms and other rooms in the house are of modest dimensions with the circulation being kept to the minimum, a function of the square plan, the space under the house is used for storage and mechanical equipment.

The entire living space is air-conditioned from a central unit, the construction is of traditional wood framing with windows built to Architect's details.







# **New Scholarships Announced**

Two architectural scholarships for the Fall of 1966 at the School of Design of N. C. State University. That was the announcement made by A. L. Haskins, president of the North Carolina Architectural Foundation at the October meeting of the North Carolina Chapter of A.I.A. at Southern Pines. This is something the architects of North Carolina have wanted to do for a long time and they expressed the hope that this was just a starter. They are concerned for the talented young men and women of our State and want to be of help where help is needed and justified.

The two scholarships will be available to the deserving junior or senior architectural student next fall at the School of Design. Final selection will be made by the Directors of the Foundation and announcements of recipients will be made next Spring on the basis of information furnished as to scholarship and need. Those desiring to be considered should file their name with Dean Henry L. Kamphoefner or with Mrs. Betty Silver, Executive Secretary of N. C. AIA.

These scholarships have been made possible by the contributions of those individual architects of North Carolina who are seriously concerned for the future of the profession in this State, and by friends of deceased members of N. C. A.I.A. The North Carolina Architectural Foundation will gladly accept contributions or bequests from members of the profession or the public and will administer such funds for scholarships and other architectural educational needs as may be requested. No gift is too small to help in the continuation of this program in other years and donations of larger amounts may be made by individuals, offices or organizations to establish through the Foundation annual scholarships for the young men and women of North Carolina.
