

F. CARTER WILLIAMS HONORED

The American Institute of Architects has announced that F. Carter Williams, FAIA, of Raleigh, N. C. has been selected to receive the Institute's Edward C. Kemper Award for 1975.

Named in honor of the late executive director of the Institute, the Kemper Award is given each year for significant contribution to the Institute and to the profession of architecture.

The award will be presented at the annual convention of The American Institute of Architects, to be held in Atlanta, Ga., May 18-22, 1975.

Williams' longstanding concern with professional ethics and judiciary matters led to his being named the first chairman of the newly organized AIA National Inquiry Committee in 1974. This committee can investigate charges of professional misconduct, hold hearings, and when warranted, act as plaintiff before professional judiciary boards.

Williams' involvement with judiciary matters includes a term as chairman of the Judiciary Committee of the N. C. Chapter AIA, a term as chairman of the Regional Judiciary Committee for the South Atlantic Region, membership and a term as chairman on the AIA National Judiciary Board, and membership in an AIA task force studying and revising the Institute's Standards of Professional Practice.

Over the past 28 years, Williams has held virtually every elective office in the North Carolina Chapter AIA. He has also played an important role in a variety of professional affairs in North Carolina. As a member of the N. C. Chapter's Contracts and Fees Committee, he was instrumental in setting up the first graduated fee schedule adopted in the state, making it possible for younger architects to take on smaller commissions at reasonable fees. While serving as co-chairman of the chapter's Legal Affairs Committee, he worked successfully for amendments and improvements to the state's Architectural Practice Act. As a member of the N. C. Board of Architecture he composed and administered a variety of professional registration examinations.

A graduate of North Carolina State College and the University of Illinois, Williams has been a principal in F. Carter Williams, Architects, since 1946.



The Jury for the 1975 NCAIA Honor Awards Program met in Cambridge, Massachusetts, in mid-December and selected some entries to receive awards. Announcement of the awards was made at a banquet on February 14 during the Chapter's Winter Convention in Winston-Salem. Jury member, Mrs. Sarah Harkness, FAIA, a principal in The Architects Collaborative firm in Cambridge, made the presentation. Other members of the Jury were Norman C. Fletcher, FAIA, principal in TAC and Eduardo Catalano, Professor of Architecture at Massachusetts Institute of Technology. The Jury had these remarks to make about the program: "There were fifty-five entries; three were given Honor Awards and five were given Merit Awards. There were many good designs so the decision of the Jury was reached only after considerable discussion and thorough review of photographs, plans and slides. The slides were particularly informative. It was more difficult for the Jury to find larger buildings in the top rank than smaller buildings, perhaps because in the smaller buildings there tended to be a more complete carrying through of details, furnishings and character." Entries selected to receive awards and all other entries, except those previously published in NC Architect, are presented on the following pages.

N. C. Architectural Foundation Establishes Fellowship



The N. C. Architectural Foundation has established a fellowship in North Carolina State University's School of Design in memory of the late William Henley Deitrick, Raleigh architect.

J. Hyatt Hammond of Asheboro, president of the N. C. Architectural Foundation Inc. and J. Norman Pease, Jr., FAIA, Charlotte architect, presented the first annual check from the Architectural Foundation to Chancellor John T. Caldwell, Dean Claude McKinney and other NCSU officials in a brief ceremony at the AIA Tower, headquarters for the N. C. Chapter, American Institute of Architects. The AIA Tower formerly housed the offices of Wm. A. Dietrick.

The annual fellowship memorializes Deitrick, an architect whose work included completion of the famed Dorton Arena at the State Fairgrounds and many other structures around Raleigh and the state. Deitrick oversaw the completion of the widely noted Dorton Arena after the original architect Matthew Nowicki died.

Rudolph Pate, vice chancellor for foundations and development, said

the annual awards will be placed in permanent trust funds of the N. C. Design Foundation, a statewide organization that raises private funds for the NCSU School of Design.

Dean of Design Claude McKinney cited the need for fellowships in school, which in recent years added graduate programs. "The financial demands of graduate professional education are so substantial that the fellowship is an important instrument in attracting outstanding students. This fellowship bearing Mr. Deitrick's name is doubly important for the School."

In presenting the first of the annual \$1,000 checks for the Deitrick Fellowships to Chancellor Caldwell, Pease said the fund was made possible by a gift from the late Mr. Deitrick and contributions from architects of the State.

Pease noted: "Bill Deitrick was a leader in his profession, a former president in the N. C. Chapter of the American Institute of Architects and winner of many awards given in recognition of his professional achievements." Participating in the presentation were (I to r) J. Norman Pease, Jr., J. Hyatt Hammond, Chancellor Caldwell, Dean McKinney, Richard L. Rice and Turner G. Williams.

Hyatt Hammond, president of the Architectural Foundation, said: "Dean Claude McKinney is making great strides with the School of Design ... North Carolina is a better state because the School of Design was organized here in 1948. Its sound influence is visually apparent in all 100 counties. With the broad vision of this University and its leaders, this School will continue to be one of the nation's leading design schools.

In addition to the Deitrick Fellowship, the N. C. Architectural Foundation awarded NCSU \$3,000 for the general fund in the School of Design, \$500 for the Leslie N. Boney Scholarship and \$2,000 for scholarships for minority students.

Pease pointed out that many of the young architects who worked in Deitrick's office were educated at NCSU.

"It seems particularly fitting," Pease concluded, "that Mr. Deitrick's contributions to his profession and state be recognized by helping prepare others for a life in architecture."



Tribute to John Tyler Caldwell


