You are accordingly notified that at the Annual Meeting of the Chapter on Wednesday, June 7, the following amendment to the By-Laws will be voted upon.


To Article 12, Section 4, Reports of Committee, add paragraph (b), so that Section 4, Reports of Committees, shall read as follows:

(a) Every committee shall make an annual report to the Executive Committee at the close of its work, and at such other times as the Executive Committee directs.

(b) The reports of Elective Committees to the Executive Committee may be presented in person by the Chairman or his representative, who shall have the privilege of discussing the subject which may be the concern of his committee.

brought us many new and younger men who may not yet be familiar with our Chapter machinery, and with these particularly in mind, we list below our more active committees with a brief description of the "sphere" of each.

Whether you be a new or an "old" member, we ask that you indicate to us on which Committee you would be interested to serve, also your suggestions as to other appointees whom you feel to be especially qualified. Constructive suggestions about these committees would be more than welcome.

Activities:

Organizes Chapter meetings, entertainments, etc. In effect, keeps the work of the committees before the Chapter membership and suggests to the Executive Committee items of interest to the Chapter.

Admissions:

Interviews and passes upon candidates for membership.

Civic Design and Development:

Is concerned with problems of City design and development; stimulates better City planning and activities for the City welfare.

Education:

Initiates and handles activities concerned with the education of the architect, both student and adult; cooperates with State Board of Examiners and Schools of Architecture on improving architectural education. Has charge of Brunner Scholarship work; will have in charge the very important matter of refresher courses for architects and draftsmen returning from military service.

Technical:

Has general charge of technical aspects of architectural practice; through a sub-committee conducts panel discussions of new building materials and techniques; through another sub-committee is working on the inauguration of an important service center for technical information on building materials and techniques; through still another sub-committee considers matters relating to the Building Code.

Legislative:

Represents the Chapter's interest in all legislation, federal, state, and local, affecting architects; in connection with the legislative work cooperates with other professional bodies.

Membership and Unification:

Recruits candidates for membership; suggests subjects for the Chapter to take up as further points of interest or help to members and prospective members; works toward unification of the profession within the A.I.A.

Fees and Contracts:

Advises on revision of fee schedules; has in charge general matters of contractual relations between architects and their clients, particularly public agencies.

Public Relations:

Presents the activities of the Chapter to the public and works toward adequate public recognition of the value and scope of architectural services.

Finance:

Handles the investments of funds in the hands of the Chapter with the advice of financial counsel and advises with regard to use of funds and the Chapter budget.

Post-war Planning:


Represents the Chapter's interests in matters of post-war planning; cooperates with other elements in the construction industry in an over-all program of postwar reconstruction and rehabilitation in the New York area.

Fields of Practice:

Stimulates broader extension of architectural services and handles activities directed toward this end.

Surveys of Unsafe Buildings:

Members of this Committee, who are recommended by the Chapter to the Civil

Service Commission are available for making Building Department surveys of unsafe buildings at a small fee.

The New York Chapter, in conjunction with the Architectural League, is holding a dinner meeting on FRIDAY, MAY 26th, at 7:30 P.M. on the subject of "Public Housing Agencies and the Architect". The Federal, the New York State, and the City Housing Agencies will be represented at the dinner; the FPHA by John A. Kervick, Director of Region II; the State Division of Housing by Ira Robbins, Acting Commissioner, and the NYCHA by John P. Riley representing Chairman Butler. The City Planning Commission has also been invited to participate.

At the same time the Architectural League will show an Exhibit of recent large scale housing projects in the New York Area.

On the following THURSDAY, JUNE 1st, at 7:00 p.m. there will be a second Housing Dinner on the subject of "Large Scale Private Housing and the Architect".

On this occasion, we hope to have guest speakers representing the bankers' approach, the insurance companies' approach, the State's approach, and possibly the real estate angle.
