NOV. 15 RELATIONS OF PRIVATE PRACTICE AND CIVIL SERVICE TO ARCHITECTURE AND PUBLIC BUILDINGS. Believing it is to the public interest that there should be better relations and more helpful cooperation between architects in private practice and in civil service bureaus, the Chapter is holding an open meeting in which representatives of the Board of Education and the Department of Public Works have been asked to participate.

Eliot Kaplan, Executive Secretary National Civil Service Reform League.

It is the purpose of our November meeting to continue this subject and promote a discussion of our mutual problems with members of Civil Service. We know you all have questions you would like to clarify in the interest of better architecture, and we hope you will bring them to the meeting. Mr. Eric Kebbon, Mr. A. Gordon Lorimer and Mr. R. B. O'Connor will be at the round table, with Mr. Holden as Moderator.

MEMBERSHIP LIMITED TO REGISTERED ARCHITECTS
The question of registration as a pre-requisite for admission to the Institute has never been quite clear. It has been discussed by our Admissions,

our Membership and our Executive Committees and finally referred to the A.I.A. for a ruling. The National Executive Committee, after extended discussion, has resolved that REGIS-TRATION SHALL BE A PRE-REQUISITE for membership in all States where a registration law exists. The only exceptions are editors of architectural magazinos and professors in schools of architecture. This decision awaits ratification by the A.I.A. Board of Directors, after which formal notification will be sent to all Chapters of the Institute. Members will accordingly PLEASE NOTE: Hereafter when asked to sponsor a candidate, make sure he is a registered architect.

RENEGOTIATION OF CONTRACTS

Any Architect or Engineer who has had contracts with the Government, under which payments to him for any purpose total \$100,000. or more, should, for his own protection, check carefully on his responsibility for renegotiation.

Inasmuch as the regulations covering renegotiation of Architect-Engineer contracts are fairly complicated, and many Architects and Engineers may not be entirely familiar with their liability for renegotiation of their contracts, the following notice should be of interest:

"For the convenience of war contractors subject to renegotiation, the War Contracts Price Adjustment Board has arranged with the Superintendent of Documents for publication of the Renegotiation Regulations in loose-leaf form. The subscription price of \$2.00 (prepaid) includes the basic 8 chapters of the Regulations and 12 monthly supplements, which will comprise revisions and additions as issued by the War Contracts Board.

"Orders may be placed with the Superintendent of Documents, Washington 25, D.C."
