Rear Admiral J. F. Jelley, Chief of Bureau of Yards and Docks, Department of the Navy, introduced by Max Foley, toastmaster, was the principal speaker. He outlined the manner in which the Bureau selects architects for its work, stressing the fact that the small office has an equal opportunity with the large one, dependent upon the nature of the commission. Architects are selected by a board of officers and civilians within a particular Naval District, preference being given to local firms if qualified. Francis Keally, Chapter President, told of his recent experiences as consultant for a new library in Berlin. Arthur Holden outlined the program and social activities being planned for the Convention in June.

#### A.I.A. CONVENTION

The 84th Annual Convention of the A.I.A., expected to be the best and largest ever, will be held in New York City this year, June 23rd through June 27th. Delegates and members from all over the United States will come here as a group for the first time in 27 years to partake in a program arranged by Arthur C. Holden's Convention Committee.

On Monday, June 23rd, the Triborough Bridge Authority will entertain 600 on a boat ride around Manhattan. Then the group will split-300 visiting Jones Beach as guests of Long Island State Park Commission, and 300 seeing New York Buildings. Both sections will be tendered dinners by their hosts.



On Tuesday, June 24th, at the Waldorf Astoria, (the convention hotel) members will hear a welcome address by President Glenn Stanton, then a symposium on the influence of steel and glass on architecture. Old papers of Denkmar Adler, Sullivan's partner, read at A.I.A.'s Nashville convention of 1896, are among those that will be discussed. Later, the gathering will adjourn to the Lever Brothers building, then will go to The Cloisters for the President's reception. Wednesday, June 25th will be highlighted by business meetings and a performance of "The King and I". 1615 seats have been underwritten for this by the American Architectural Foundation. On Thursday, June 26th, there will be a discussion on structural design and

progress in reinforced concrete, a luncheon addressed by industrialists, in conjunction with the Building Congress, and a dinner banquet at which 77-year old French architect Auguste Perret will receive the A.I.A.'s Gold Medal. On Friday, June 27th, delegates will view the U.N. then attend the closing meeting. This will be followed by a luncheon of Fellows.

The Convention, of course, costs money. Registration fee will be \$12.00 per member, plus \$3.00 per guest. New York members are urged to buy their tickets in advance, so that the Convention Committee can know how many to count on. Make reservations at A.I.A. Convention Headquarters, 115 E. 40th St., N. #### IN AND AROUND MANHATTAN

It's time you walked past LEVER HOUSE, at Park Avenue and 53rd Street. Many times during the coming season you'll be called on to answer the "Oh -- you're an architect; what do you think of ..." type of question regarding this distinguished building and you might as well start formulating your answer now.

Rising our of the Jersey Flats between Newark and the Hudson is to be seen a structure not less impressive than Stonehenge, and hardly less mysterious, until you identify it as a chunk of the new New Jersey Turnpike. It sweeps up over rivers and down under existing causeways in a manner quite suggestive of the 60 mile fair-weather speed limit. The long, flexible ribbon of roadway is supported on concrete bents which are flawless in their perfection and simplicity of form, and the bridges, while not notable for any staggering length of span are certainly so for their exquisite marriage of girder and pier. We have again in this country something worthy of publication in the Proceedings of the Swiss Society, Professional, of Engineers, Civil.

Over on Eighth Avenue at 41st Street is a most interesting three-dimensional essay in handling many people and many vehicles at many levels — three-dimensional with a vengeance. It's the huge Port Authority Bus Terminal and it's been in operation for well over a year now. Have you seen it at work?

#### EXHIBITIONS
