# LETTER TO THE EDITOR:

At the Chapter meeting on May 17th to vote on withdrawal from the Architects Council, discussion by individuals was limited to two minutes. I would appreciate an opportunity to complete the statement I made from the floor of that meeting.

I was in favor of the resolution to withdraw but not for the reasons most often advanced. I don't believe disproportionate representation was in itself a sufficient cause for the break. I also do not feel that the Chapter's public "image" was seriously damaged by association with our colleagues in Staten Island or the Bronx. My own reason was that the profession in New York City sorely needs a single, unified Chapter of the A.I.A. and that the Council is actually a roadblock to that goal.

Our main professional problems are first, Standards (i.e. standards of competence and standards of compensation) and second, Public Service (i. e. leadership in city planning, public building, etc.) In my opinion, little progress has been made in New York along these lines by the architectural profession in recent years.

I recognize that changing the organizational form of the profession in New York City will not of itself solve anything. There must be a clear policy and a will to carry it out. But recent experience with the Council persuades me that we are more likely to make headway toward improved professional standards and increased public service if all of the architects of the city are in a single chapter of the Institute.

It seems to me that only if it leads in this direction will withdrawal from the Council realize its full potential for good.

#### CHAPTER HONORS

A city planner, an architectural critic, a writer, a publisher and a student planning to enter an architectural school this fall were honored at the annual meeting of the New York Chapter on June 1st.

James Felt, Chairman of the City Planning Commission, was given the Chapter's Award of Merit in recognition of his integrity and dedication as a public servant with the most laudable ambition to create a new zoning ordinance for the City of New York.

Lewis Mumford, was made an Honorary Associate member of the New York Chapter of the A.I.A., at the same luncheon meeting.

On behalf of the A.I.A.'s Annual Architectural Journalism Competition Jury, the Chapter also awarded Certificates of Merit to Time Magazine, the Nation and Horizon Magazine. The jury cited Time Magazine "for the excellence of a continuing series of the Nation, received that magazine's award, giv-Jones, writer of the series accepted the award on behalf of the magazine. George Kirstein publisher of the Nation, received that magazine's award, given "for excellence of a series of articles on architecture." The magazine Horizon was honored also by a Certificate of Merit. An article on architecture by Grady Clay, real estate editor of the Louisville Courier, run in Horizon Magazine, won first prize in the journalism competition. Eric Larrabee, of the American Heritage Publishing Company, Inc., publishers of Horizon, received the award.

The late Bassett Jones, an engineer who developed lighting systems and elevators for skyscrapers, was honored by a special citation from the New York Chapter "in affectionate memory of his distinguished contributions to the technical development of architecture and his stimulating collaboration with its practitioners."

For the second year the Plastering Institute of Greater New York awarded a \$1,000 scholarship, administered by the New York Chapter of the A.I.A, for the use of an architectural student entering school this fall. This year's winner is Donald Ira Liss of Long Island City, a student at the High School of Music and Art, the Bronx.

The meeting then proceeded to the election of officers and elective committees who are listed on page one.

This year, of 327 ballots turned in, 45 were void!

The City Civil Service Commission has established the following procedures for the filing and receipt of applications for the Mayor's Panel of Architects.

Application blanks are obtainable by the applicant in person or by his representative at the Application Section of the Department of Personnel at 96 Duane Street, Manhattan, New York 7, New York. They will be mailed on request provided that the request to the above section is accompanied by a stamped (4 cents) self-addressed 9½-inch envelope for each application requested.

All applications with accompanying photographs, where required, must be mailed or delivered to the Department of Personnel, Examining Service Division, Room 210, 299 Broadway, Manhattan, New York 7, New York, not later than October 27, 1960.

Applications will be examined by an Architectural Jury appointed by the Presidents of the following societies and recommendations will be made by them to Mayor Robert F. Wagner for his 1960 Panel of Architects:
