ARCHITECTS SELECTION BILL ON HOLD TILL AFTER ELECTION

H. B. 977, the bill that would put into law the A/E selection process ASO recommended last Fall, has been put on hold until after the November election in an effort to remove it from the political debate surrounding the gubernatorial election.

The bill was introduced by Rep. Paul P. Mechling (D-Thornville).

State Architect *Carole J. Olshavsky, AIA*, has already put into practice many of the changes recommended by H. B. 977 as she implements the current capital improvement bill.

1987 SLATE OF OFFICERS Nominating

Committee Chairman, Carole J. Olshavsky, AIA, has announced that Presidentelect Robert E. Gramann, FAIA, Cincinnati, will become President of ASO for 1987. According to the ASO bylaws, the move from President-elect to President is automatic.

Gramann is a past vice president of the AIA and has represented the Ohio Region as Regional Director. While on the AIA Board, he served as Chairman of the Membership Services Commission, the Member/Component Affairs Commission, the National Convention Site Selection Task Force, Chairman of 1982 Grassroots in Washington, D.C., the SAA Name Change Task Force, the Architects in Industry Committee and the Planning Committee.

For eight years, Gramann served the Architects Society of Ohio as Board Member chairing various committees, served as Treasurer in 1984 and is the 1986 convention chairman. His service to the Cincinnati Chapter includes director, secretary, vice president, president (1977) and member of the 1980 National Convention and Guide Book Steering Committees. He is currently on the AIA Foundation Board of Directors.

TREASURER: Kenneth J. Fogle, AIA

As the incumbent for the second year of his term as Treasurer, Kenneth J. Fogle, AIA, Cleveland, has jointly formed the architectural firm of Fogle Stenzel Architects, Cleveland. He has directed program and project management for the Cuyahoga County Board of Mental Retardation's \$22 million dollar, eleven building, capital improvement program. Independent consulting experience includes population and program analysis for the Ohio Association of Boards of Mental Retardation and specialized development in East Africa.

Other activities include the 1983 Group Study Exchange Award to Southeast Asia sponsored by Rotary International and Chairman of the Governors C.O.N. task force for long term care modernization.

ASO ACTIVITIES AND RECENT ACCOMPLISHMENTS

In the Legislative/Regulatory area:

LEGISLATIVE

1) Developed an ASO "merit selection" bill supported by the Administration and introduced by Rep. Paul Mechling as H.B. 977. Obtained support of the measure from the Ohio Association of Consulting Engineers (OACE) who previously opposed some aspects of the ASO proposal.

- 2) Testified in support of a Board of Registration proposed revision of the Architects Registration Law, S.B. 292. The bill was then voted out of committee. It contains a section that removes the section of law that specifically allows non-registered architects to file plans with plans approval agencies. And it shifts from experience to education as the basis of the prospective architect's qualifications.
- 3) Obtained an amendment to the recent Insurance Reform Act of 1986 that specifically mandates insurance companies to provide break-out information relative to professional liability policies sold in Ohio covering architects and engineers. When the bill was drafted, lawyers, accountants, etc. were included, but architects were omitted.
- 4) Testified in favor of various tort reform measures (frivolous lawsuit, etc.) aimed at bringing the cost of liability insurance down to reasonable levels.
- 5) Reviewed each bill introduced during the 116th Ohio General Assembly for ramifications to the architect and answered many questions from members about a variety of them.
- 6) Our Legislative Committee met, reviewed the proposals, and made policy recommendations to the ASO Board.
- 7) We recently sent a detailed legal memorandum to all ASO Principals concerning potential problems with the new Ethics Bill that prohibits firms, employees, etc. from contributing in excess of \$1,000 to any governor's campaign and also obtaining state work.

POLITICAL ACTION COMMITTEE

ASO staff revived the dormant PAC. A new Board was recruited. It met several times, planned and implemented a fund raising campaign, hired a consultant to implement it and recently selected recipients for the funds.

DEPARTMENT OF INDUSTRIAL RELATIONS

ASO has held ongoing meetings with Department of Industrial Relations chief, Jim Harris, and his assistant, Joe McLean. Here are some of the things we have obtained and asked for:

- 1) Shortened "shelf time." Two years ago it was over two months both in Akron and Columbus. It has been zero this year in Akron and two weeks in Columbus recently.
- 2) Suggested that F&B use part-time architects to work off shelf time. This was rejected due to complications with the state's pay system.
- 3) Suggested use of retired architects on part time basis. This was agreed to and we advertised for them in ARCHITYPES.
- 4) Advertised for plans examiners in ARCHITYPES.
- 5) Asked Harris, McLean et. al. to take an F&B "Road Show" to all ASO chapters to get input from local architects on how to improve the F&B operation. Not only did they agree, they went twice to Eastern
- 6) Asked for the ability to make appointments for out-of-towners so architects wouldn't have to wait all morning or afternoon at F&B. They implemented this but scrapped it when architects tried to manipulate the system by making several appointments way ahead, then failing to show up without cancelling them.
- 7) Asked for a Supervisor of Plans Approval. Got one.
- 8) Asked for the restoration of the preliminary plans approval process. Got it, but had problems due to the fact that the examiner who gave the preliminary approval wasn't the one who did the final approval. We're trying to get this cleared up now.

RELATIONS WITH ALLIED GROUPS

ASO has instituted periodic meetings with the Associated General Contractors which have brought about a good exchange of ideas and some exchanged support on various issues. Meetings have been held both in Columbus and Cleveland on such subjects as: liability insurance, construction management, etc. Plans are to extend such meetings to members of the Ohio Association of Consulting Engineers (OACE) during 1987.

RELATIONS WITH STATE ARCHITECT

ASO staff was asked for input relative to the selection of a new state architect when Lee Martin left that office. Staff consulted with the Board and provided Board input.

Since Carole Olshavsky, AIA, became the State Architect, ASO staff and members have worked closely with her on a variety of items including the proposed "Merit Selection" bill, project notification, use of revised Federal Forms 254 and 255, etc. all of which have been well received by architects.

RELATIONS WITH THE GOVERNOR'S OFFICE (Boards and Commissions)

ASO has been consulted about each vacancy that has occurred within the Board of Registration. ASO has provided the Governor's office with a list of several acceptable individuals each time.

RELATIONS WITH AIA

Each time ASO has been asked by AIA to contact state Congressmen or Senators on specific issues, the contact has been made immediately. When additional information was requested by legislators, staff has obtained and conveyed it.

In addition, ASO members and staff have visited Ohio Congressmen and Senator Glenn in their Washington offices where they have discussed issues of importance to all architects.

Finally, ASO's executive vice president was invited by AIA to Washington for a specialized meeting of those state executives who deal extensively with architectural legislation.

Several years ago ASO set out to strengthen its legislative/regulatory arm. Clearly that job has been done.

OAPAC CONTRIBUTIONS BALANCED It's an

election year—our chance to help those legislators who have helped us with our various legislative efforts. The PAC Board met August 27 and made its allocations for this election. Contributions were about evenly divided between Republicans and Democrats.

POLITICAL CONTRIBUTIONS

The new Ohio Ethics Law contains a provision that bars the awarding of any contract for purchase of goods and services which is not competitively bid, if the person seeking the contract has within the previous two calendar years, made contributions in excess of \$1,000 to a candidate or holder of a public office having ultimate responsibility for award of the contract.

The statute is drawn to cover contributions by partners, firm members, share-holders of professional associations, employees, associates, etc. including their spouses. In group practices, contributions of partners, members, shareholders, etc. would be aggregated for the purpose of the \$1,000 limit.

The statute provides that the Governor has ultimate responsibility for award of a contract if the public officers responsible for the award of the contract is appointed by the Governor.

If you have concern, we suggest you contact your attorney.

ETHICS BILL DISCLOSURE

Effective September 17, if you want to do non-bid work for the state, you must complete and return to the appropriate state agency a statement attesting to the fact that (owners, employees, associates, 20% owners, etc.) have not contributed more than \$1,000 to the Governor's Committee, the campaign committee for Governor Celeste, in the previous two calendar years.

Various state agencies sent forms to prospective suppliers of goods and services in mid-September.

Recipients were asked to complete the one that appropriately describes their method of doing business, i.e., corporation, partnership, etc. and return it to the agency.

The information on the form is to be updated if the ownership or contributions change.

The disclosure statement is the result of passage this session of the Ohio General Assembly of Sub. H.B. 300 commonly referred to as the "Ethics Bill."

ARCHITECTS' TESTIMONY KEY TO INDICTMENTS

Toledo and Columbus architects played key roles in the June indictments of Democratic Party finance director, Pamela Conrad, by a special grand jury appointed to investigate allegations of corruption in the Celeste Administration.

Conrad was charged with soliciting a campaign contribution to the Governor's Club and the Governor's Golf Outing from *Leland Brubaker*, *AIA* Columbus and from *Melvin Mull*, Toledo, for the Governor's Club.

The contributions were sought in return for receiving state business, according to the indictment.

Conrad was indicted on three felony counts of bribery involving the exchange of political contributions in return for state business and on one felony count of perjury.

Former executive aide to Governor Celeste, Larry McCartney, was indicted on one felony count of perjury in connection with his appearance before the special grand jury.

Four other present and former state officials were named in the indictment as having been involved in the bribery scheme, but were not indicted. They are Ohio State Fair Manager Jack Foust, Assistant Transportation Director, Bernard B. Hurst, Public Works Deputy Director, Daniel F. Shields, and former State Architect, Lee Martin.

Governor Celeste contends the special grand jury indictments are a political ploy of his opponent in the November election, former Governor James A. Rhodes.

STATE ARCHITECT SENDS LIST OF 25 DESIGN PROJECTS State Archi-

tect, Carole J. Olshavsky, AIA this summer sent a list of 25 upcoming capital improvement projects to interested architects, professional engineers and landscape architects. The list was sent to professionals who have expressed an interest in preparing plans and designs for state construction and remodeling projects.

The list of projects was submitted to DAS by state agencies and two-year and fourcontinued on page 10







1986 "EXCELLENCE IN MASONRY" **ARCHITECTURAL AWARDS** PROGRAM AT THE OLD, OLD POST OFFICE An

anticipated annual event, the Masonry Design Awards Program sponsored by the Ohio Masonry Council, gives recognition to architects by their peers in the masonry industry as well as motivation to strive for excellence in design with masonry.

The setting for this year's ceremony couldn't be more appropriate. The Old, Old Post Office is listed on the National Register of Historic Places, is a sensitive combination of the original (1887) structure and the later (1912) addition. The original building can best be described as Romanesque Revival- a style characterized by massive masonry walls and large, arched openings. The designer of the 1912 addition was able to increase the size of the building, create a new structure and change the style of the original to a more "modern" style commonly referred to as a High Victorian Gothic.

The interior of the Post Office, also architecturally significant, is full of details, materials and workmanship not commonly available today. Included are the multicolored marble fireplace surrounds, marble wainscots, and the courtroom with its marble or carved oak wainscot and coffered ceiling. Both stairways exhibit unique designs; one is decorative cast and wrought iron, while the main stairway is almost entirely made of marble.

At one time Central Columbus could boast several large, massive Romanesque or Gothic style buildings. Only the Old, Old Post Office remains. In addition, the building is one of the only remaining major 19th century buildings left on Capital Square. Its return to use is a bright moment in the city's history.

year educational institutions. DAS, with input from an advisory committee, will submit a list of three or more qualified professionals for each project to the participating agency.

The list of projects requiring design services by region includes:

SOUTHWEST OHIO

Dayton Mental Health Center, Dayton—Building renovations are planned for several buildings. The total project cost is \$470,000.

NORTHWEST OHIO

Toledo Mental Health Center, Toledo—Building renovations are planned for two buildings. The total project cost is \$2.4 million.

Ohio Veterans Home, Sandusky—A master plan will be prepared; to provide for long-term care needs of Ohio's veterans. The project cost is \$50,000.

CENTRAL OHIO

Ohio Expositions Commission, Columbus—Interior renovation is planned for the Agriculture Center and Heritage Hall. The total project cost is \$110,800.

Ohio Expositions Commission, Columbus—One project includes replacing the roof, installation of heating, ventilating and air conditioning, and related repairs to the Arts and Crafts Building. The total project cost is \$184,700.

Kent State University, East Liverpool Campus, East Liverpool—This project includes expanding the existing library, property acquisition for parking, roof renovations for the auditorium, and renovations to the main building and auditorium. The total project cost is \$565,000.

Woodside Receiving Hospital, Youngstown-Building renovations and repairs and resurfacing to parking lots and roads are planned for the hospital. The total project cost is \$340,320.

TORT REFORM/ **INSURANCE** REFORM PASSES HOUSE The Ohio House

has passed an omnibus bill aimed at restoring balance to the civil justice system and increasing the availability and affordability of liability insurance.

Most observers consider it only moderate tort reform and some believe the new burdens placed upon insurers will only serve to increase their costs without solving the availability problem.

There is some optimism that the availability problem will be helped by one provision of the bill which would allow banks to invest in reinsurance companies. The goal is to pump more capital into the reinsurance marketplace in hopes of freeing up the current constriction.

The House measures were folded into a tort reform bill, Sub. S.B. 330, that had already cleared the Senate. The bill is now being studied by a House/Senate conference committee whose membership includes: Senators H. Cooper Snyder (R-Hillsboro), David Hobson (R-Springfield) and Lee Fisher (D-Celveland) plus Representatives Michael Stinziano (D-Columbus), John Shivers (D-Salem) and Louis Blessing (R-Cincinnati).

CONFUSION RESULTS FROM AIA INSURANCE TRUST CHANGE

AIA's Insurance Benefit Trust has changed administrators. Out is Association Administrators and Consultants Inc. (AA&C). In is Kirke-Van Orsdel, Inc. (KVI). The change has not been without bitterness.

AA&C objected to the action and refused to convey insurance records to KVI. The Trust sued for the records and a Federal District Judge issued a temporary restraining order for AA&C to turn over the records and not to communicate with any participants without prior approval of Trust trustees.

That court order has been removed and the old administrator, AA&C has concontinued on page 12






